# **Eligibility Requirements**

- Latinx currently enrolled as a college freshman or sophomore at the time of application. Upper classmen and graduates will also be considered.
- Ability to demonstrate strong academic potential with a minimum overall B average and to permit LatinoJustice PRLDEF access to your academic record.
- Must demonstrate an interest in pursuing a legal education.
- Must be able to attend the full prep program, which takes place daily from 9:30AM to 4:30PM, from January 7<sup>th</sup>, 2019 to January 11<sup>th</sup>, 2019. Applicants from outside of the New York City/Tri-State area must secure their own local housing if accepted to the program.
